

## Privacy Policy

### 1. Data Protection as Principle

### Right on Information, Correction, Blocking or Deletion

You have the right to receive information on origin, further recipients, duration of storage and purpose of processing of your personal data free of charge at any time. ## 4. Automatically stored data on server log files

Upon usage of our internet presence, we and our hosting service provider respectively store the following access data according to Article 6 para. 1 lit. f GDPR in so called server log files

- the names of the websites you access
- Referrer URL (the website visited before)
- the browser and operating system you use
- date and time of access
- the search engine you use
- data volume and name of downloaded files
- and your IP address

We evaluate these data anonymously and for statistical reasons only to constantly improve our web presence and make it more attractive.

## 5. Usage of Cookies

When you access our websites, we may store information by way of cookies on your computer. Cookies are little text files which are sent to your browser by a web server and that are stored on your hard disk drive. However, no personal data of the user are stored.

You may use our websites without cookies. To do so, please prevent the storage of cookies on your computer by choosing “Block Cookies” in your browser settings.

## 6. Usage of Google Analytics

Our website uses Google Analytics, a service provided by Google Inc. to analyze the web. Google Analytics uses cookies to analyze the usage of our website. The information generated by cookies on usage of this website are usually sent to a Google server in the US where they are stored. On behalf of the provider of this website, Google will use this information to evaluate the usage of the website, to compile reports on the website activities and provide further services for the website provider with regard to the usage of the website and services in connection to the usage of the internet. Google will not merge your IP address with other data. You can block the storage of cookies by the respective browser setting.
